Emphasises the Potential of AI as a means of improving the quality of lives for all,

Considers the Potential threat posed by AI and the vitality using AI as a force for good,

Noting with deep concern how AI has provoked accelerated hacking and the exposure to viruses and AI terrorism due to the update and availability of software,

Alarmed by the significant elimination of human's needs which can take the place of professionals and the heavy reliance on this technology today,

Emphasising that the Commission on Science and Technology for Development plays an important role in developing ways in which technology can serve as facilitators of the 2030 agenda which draws attention to key sectors of the economy and the emerging and disruptive technologies,

1. Urges all members to support the creation of a new un group the AIMC (Artificial Intelligence Monitoring Committee) to manage the development of Artificial intelligence which would consist of three different sections:
 - a. Development of artificial intelligence to benefit humanity,
 - b. Debate and recommendations of how to implement policy concerning the ethical uses of artificial intelligence,
 - c. Emergency Protocols in case it becomes overly biased or controlled by other states;
2. Praises the People's Republic of China for their continued investment in the development of artificial intelligence and aiding other countries for the implementation of such technology in order to better and protect its citizens lives;
3. Encourages all member states to invest into developing programs similar to Ada Health which has recently managed to provide basic medical care to millions in the countries of Mozambique, Tanzania, Kenya and Uganda;
4. Urges all to invest into artificial intelligence research and programs as a tool for human development, such programs include but are not limited to:
 - a. Research into the potential role of artificial intelligence in,

- i. Education,
 - ii. Medical Care,
 - iii. Human Rights,
 - iv. Security,
 - b. Developing new and more efficient versions of AI,
 - c. Problems surrounding climate change;
- 5. Strongly encourage all countries to implement policy to grant job security to the jobs which potentially can be phased out due to artificial intelligence. Programs dedicated to this cause include but are not limited to:
- 6. All countries to implement policies and programs to grant job security under the threat of AI job displacement which will:
 - a. Guarantee Job training for those who lose their jobs,
 - b. Implement programs in schools to insure that generations to come understand AI and can navigate the potential complexities of the new workforce;
