**Topic**: Establishing measures to address the conflict between Turkey and armed Kurdish Groups

The United Kingdom of Great Britain and Northern Ireland

In the name of peace, security, and diplomacy, the delegation of the United Kingdom,

*Recalling* the principles enshrined in the Charter of the United Nations, which emphasize the sovereign equality of all Member States, the peaceful settlement of disputes, and the promotion of international cooperation,

Acknowledging the significance of regional stability in fostering global peace and security,

*Deeply* concerned about the ongoing conflict between Turkey and armed Kurdish groups, recognizing its impact on the civilian population, and affirming the urgency of addressing this issue to prevent further humanitarian crises,

Affirming the commitment to the territorial integrity, sovereignty, and political independence of all states, including Turkey, while also recognizing the legitimate aspirations of ethnic communities for self-determination,

*Emphasizing* the importance of dialogue, negotiation, and diplomatic means in resolving conflicts, and encouraging all parties involved to engage in constructive and inclusive talks to find a lasting and comprehensive solution,

- 1. *Urges* all Member States to work in coordination with international humanitarian organizations to ensure the delivery of humanitarian aid to affected populations in a timely and unimpeded manner, through methods such as but not limited to:
  - a. Sending the NGO doctors without borders to the Turkish Region of Kurdistan and Turkey Respectively,
  - b. Redirecting funding from military operations into healthcare,
  - c. Setting up temporary aid and shelter areas throughout regions in forms such as but not limited to:
    - i. Refugee shelters,
    - ii. Medical camps,
  - d. Food aid;

- 2. *Demands* for the creation of a UK lead Special Envoy for the Turkey-Kurdish conflict, tasked with facilitating diplomatic talks, promoting dialogue, and seeking a peaceful and sustainable resolution to the conflict by allowing actions such as:
  - a. Mandating the Special Envoy to collaborate closely with regional organizations, neighboring states, and relevant stakeholders to ensure a comprehensive and inclusive approach to conflict resolution,
  - b. Ensuring the Special Envoy reports regularly to the Security Council on the progress of diplomatic efforts, challenges faced, and recommendations for further action;
- 3. Demands for an immediate ceasefire within the Turkish Kurdistan Region;
- 4. *Demands* that UN Peacekeeping troops are sent to the Region of Turkish Kurdistan, in order to protect citizens;
- 5. *Condemns* Turkeys discrimination against the Kurdish inhabitants, despite them being citizens of the state;
